Excerpts from the Minutes of a Meeting of the Board of Directors of _____
_____ held at _____ on this _____ day of _____ 20.....

It is hereby resolved that the Company do obtain from Pan Asia Banking Corporation PLC, Pan Asia Business Internet Banking Facility and delegate the required authority and limits upon persons nominated by the Company from time to time to act as “Inputters”, as “Authorizers” and as “Company Administrators” for the functions permitted from time to time for and behalf of the Company under Pan Asia Business Internet Banking Facility, and that the Company do indemnify the Bank against any loss, damage, or detriment of whatsoever kind or nature occasioned through the Company using Pan Asia Business Internet Banking Facility whether as a direct result thereof or otherwise.

It is further resolved that the Company do sign execute and deliver to the Bank agreeably and in conformity with the Articles of Association of the Company all applications, indemnities, terms and conditions, agreements and any other document of whatsoever kind or nature as may be required by the Bank in connection with obtaining the said Pan Asia Business Internet Banking Facility and that every such writing be entered into on behalf of the Company signed under the name of the Company by any two directors of the Company or by one director and the Company Secretary as prescribed by the Articles of Association of the Company and place the common seal of the Company.
